COMMUNITY UPDATES

Parking

- New parking guidelines were approved.
- Guest parking lot is open to all from the hours of 6am-12am, and from the hours of 12am-6am restricted to all residents, and guests without advance approval. Guest requests will be limited to 5 annually, before additional resident and vehicle information may be requested.
- Guest Parking Requests must be submitted **no later than 8pm daily**, using the link on the community webpage.

Pool

Paver coping project began on 4/18/23, but encountered delays with materials.
 Anticipated completion is on target for April 27th, 2023.

Front Pedestrian Gate

• New gate keypad approved for replacement, date being scheduled.

Light Pole

 Pole on 78th St is secured for safety. Work order placed, as of January work ordered are out 6-12 weeks.

Landscaping
